BLACK/WHITE LOGO USAGE



This is the single color logo and should be used when the process or two color version is not possible.

One Color: Black (K100) It may be used on any light color background.

Usage: Corrugated Shipping Boxes, Newsprint, Corporate Apparel (Screen Printing), Promotional Items (Screen Printing, Debossing and Embossing of Leather, Vinyl, or Paper Products), Corporate Gifts (Laser Engraving)



This is the single color logo and should be used in white reverse print on a dark background when the process or two color version is not possible.

Usage: Corrugated Shipping Boxes, Corporate Apparel (Screen Printing), Promotional Items (Screen Printing, Debossing and Embossing of Leather, Vinyl, or Paper Products), Corporate Gifts (Laser Engraving)

INCORRECT LOGO REPRODUCTION



Do not reproduce in a tint or a screen



Do not modify the logo



Do not reproduce in other colors



Do not resize or change the position of the logo elements



Do not reproduce like this on a dark background



Do not squish or squash the logo. Resizing must be proportional.



Do not cut off any part of the logo

IDENTITY REPRODUCTION

Each version of the logo, consisting of the underlined text and red dot, is a self-contained unit and should not be altered in any way. Kindly observe the minimum clear space as indicated.



Logo Clear Space

- Arrows indicate the minimum required clear space surrounding the logo.
- The clear space is equal to the width of the bar of the D. The width of the clear space is equal to its height.
- Surrounding elements can be safely positioned up to the arrows.
- The logo must be positioned a minimum half inch away from the edges of documents.

Logo Construction

- Ensure the overall logo size is large enough that all words are legible.
- Whenever possible, use the vector files of the logo for clean reproduction.
- Use only the artwork from the electronic files supplied.
- Do not recreate this logo using typography.

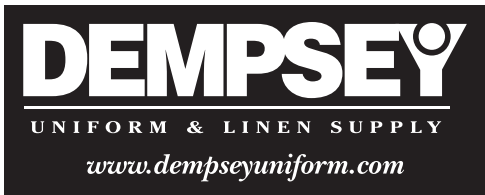

- Generate mutually beneficial results for both parties
- Allow us to partner with a highly reputable organization
- Create new revenue streams without cannibalizing existing ones
- Allow us to more efficiently and effectively reach specific goals
- Enable both parties to leverage each other's relationships, market share, and/or influence to appeal to a new or expanded audience
- Position our brand in a positive light
- Provide an opportunity to create a formal co-branding agreement that includes a sales and marketing plan
